RESOLUTION OF THE MUNICIPAL ADMINISTRATION OF JUNCOS, PUERTO RICO, TO AUTHORIZED THE AUTONOMOUS MUNICIPALITY OF JUNCOS TO REQUEST AND OBTAIN FINANCIAL ASSISTANCE FOR THE SECTION 533 PROGRAM, HOUSING PRESERVATION GRANT OF THE UNITED STATES DEPARTMENT OF AGRICULTURE, RURAL AND ECONOMIC COMMUNITY DEVELOPMENT OFFICE, PART 1944, SUB PART "N" OF THE 1949 FEDERAL HOUSING LAW, AS AMMENDED; FOR THE PURPOSE TO REQUEST A GRANT FOR THE RECONSTRUCTION OF HOUSES FOR PERSONS WITH VERY LOW INCOME; AND FOR OTHER PURPOSES.

WHERE AS: The Autonomous Municipality of Juncos is planning to start a housing preservation and reconstruction project for persons with very low incomes.

WHERE AS: This Municipality has a policy to offer services to people with low living resources in the area legally under their jurisdiction without prejudice because of gender, race, color, sex, age, sexual orientation, religion, national origin, veteran condition or political affiliation.

WHERE AS: In order to complete the much needed funds to incorporate this project, the Municipality needs \$50,000.00 and cannot get the funds from other sources due to the actual economic conditions, high interest rates, and other conditions.

WHERE AS: The Municipality will submit a proposal to obtain the necessary funds to complete the Section 533 Program, Housing Preservation Grant of the United States Department of Agriculture, Rural and Economic Community Development Office, Part 1994, Sub-Part "N", of the 1949 Federal Housing Law, as amended.

THEREFORE: **RESOLVED BY THE MUNICIPAL LEGISLATURE IN JUNCOS, PUERTO RICO, AND MEETING IN AN ORDINARY SESSION TODAY JUNE 25th, 2019 THE FOLLOWING:**

SECTION 1ST: The Autonomous Municipality of Juncos is authorized to submit a proposal to request funds for the reconstruction of housing for people with very low income.

SECTION 2ND: The Hon. Alfredo Alejandro Carrión, Mayor, is authorized to accept the conditions established by the Section 533 Program, Housing Preservation Grant of the Unites States Department of Agriculture, Rural and Economic Community Development Office, Part 1994, Sub-Part "N", of the 1949 Federal Housing Law, as amended, that need to be completed before the financial assistance can be obtained.

SECTION 3RD: To offer the services as stated by the program within its recourses to the residents of the service area without discrimination due to gender, race, color, religion, sexual orientation, national origin, veteran condition or political affiliation at a reasonable cost.

SECTION 4TH: Authorize the contracting of professional o advisory services where it is specified that the payment of non-fees will be subject to approval of the proposal and the signing of the contract between the Municipality and the Rural Economic Development Office.

SECTION 5TH: The Hon. Alfredo Alejandro Carrión, Mayor is authorized to comply with, sign for and on behalf of the Municipality all the necessary and required documents, forms as requested by the Section 533 Program, Housing Preservation Grant of the Unites States Department of Agriculture, Rural and Economic Community Development Office, Part 1994, Sub-Part "N", of the 1949 Federal Housing Law, as amended.


SECTION 6TH: Authorize the realization of the project of reconstruction of homes to people of very low income by the Autonomous Municipality of Juncos.

SECTION 7TH: This Resolution will take effect once it is approved by the Municipal Legislature and signed by the Mayor.

SECTION 8TH: Copy of the Resolution will be sent to the Office of Management and Budget (Municipal Management Division), Department of Agriculture, rural and Economic Community Development Office, Municipal Finance Office, Municipal Secretariat Office, Internal Audit Office, Federal Affairs Secretariat and any other agency o municipal agency that corresponds.
