RESOLUTION OF THE MUNICIPAL ADMINISTRATION OF JUNCOS, PUERTO RICO TO AUTHORIZE THE MAYOR OF JUNCOS, HON. ALFREDO ALEJANDRO CARRIÓN TO APPROVE THE SAFETY PLAN FOR THE TRANSPORTATION OF BUSES REQUIRED BY THE FEDERAL TRANSPORTATION AGENCY (FTA); AND OTHERS.

WHERE AS:

Law Number 107 approved on August 14th, 2020, known as the Municipal Code of Puerto Rico set in the Book I-Municipal Government, Chapter III - Powers of attorney and Powers of the Mayor, Article 1.018 - Powers, Duties and Functions of the Mayor, subsection (a) and (d) the following:

- "(a) Organize, direct, and supervise all the functions and administrative activities of the municipality.
- (d) Comply with and enforce duly approved municipal ordinances, resolutions, regulations, and provisions."

WHERE AS:

Law Number 107 approved on August 14th, 2020, known as the Municipal Code of Puerto Rico set in Book I-Municipal Government, Chapter III - Powers of attorney and Powers of the Mayor, Article 1.019 - Obligations of the Mayor with respect to the Municipal Legislature, subsection (a) the following:

"(a) Present for the consideration and approval of the municipal Legislature the project ordinance and resolution required by law."

WHERE AS:

Law Number107 approved on August 14th, 2020, known as the Municipal Code of Puerto Rico set in Book I - Municipal Government, Chapter V - Process Municipal Legislature, Article 1.039 - General Powers and Duties of the Legislature, subsection (m) the following:

"(m) Approve those ordinances, resolutions and regulations on matters of municipal jurisdiction that, according to this code or any other law, must be submitted to its consideration and approval."

WHERE AS:

On July 19th, 2018, the Federal Transportation Agency (FTA) published the Final Rule of the Public Transportation Agency Safety Plan (PTASP), which requires that certain operators of public transportation systems that receive federal funds under the FTA Urbanized Area Formula Grants they have to develop a safety plan that includes the processes and procedures to be implemented for these purposes, in order to receive and participate in the programs and funds of this agency.

WHERE AS:

The purpose of this plan is to minimize security problems that may occur in the operation of the collective transportation system and guarantee the safety of passengers and drivers of collective transportation vehicles and facilities.
