RESOLUTION OF THE MUNICIPAL ADMINISTRATION OF JUNCOS, PUERTO RICO TO AMENDMENT RESOLUTION NUMBER 34 SERIES 2020-2021 ENTITLED RESOLUTION OT THE MUNICIPAL OF JUNCOS, PUERTO RICO TO AUTHORIZE THE MAYOR OF JUNCOS, HON. ALFREDO ALENJANDRO CARRION TO APPROVE THE SAFETY PLAN FOR THE TRANSPORTATION OF BUSES REQUIERED BY THE FEDERAL TRANSPORTATION AGENCY (FTA) IN SECTION 4, SECURITY POLICY MANAGEMENT AND AMENDING SECTION 5, SECURITY AND RISK MANAGEMENT AND OTHER PURPOSES:

WHERE AS: After having received the new FTA guidelines is necessary to amend the Resolution Number 34 Series 2020-2021, that they are in accordance with the established new regulations.

WHERE AS: It is necessary to amend section 4, Management of the Security Policy and amend Section 5, Risk and Security Management.

WHERE AS: **RESOLVED BY THE MUNICIPAL LEGISLATURE OF JUNCOS, PUERTO RICO, MEETING IN EXTRAORDINARY SESSION TODAY, DECEMBER 17, 2022, AS FOLLOWS.**

SECTION 1: Amend the Safety Plan of the Public Transportation Agency for the transportation of Buses required by the Federal Transportation Agency (FTA).

SECTION 2: Amend Section 4 Administration of the Safety Policy to add a fixed route driver and add an administration employee; Federal Affairs Secretary Accountant.

SECTION 3: Amend Section 5 risk and security management; to add the risk reduction program guidelines and eliminate transmission disease guidelines.

SECTION 4: This Resolution is urgent and necessary, it will be effected immediately after its approval by the Municipal Legislature and after it has been signed by its President and Mayor.

SECTION 5: Copy of this Resolution, duly certified, will be sent to State Department, Mayor's Office, Financial Office, Municipal Secretariat Office, Secretariat of Federal Affairs Office, Municipal Emergency Management Office, Municipal Transportation Office and any other agency or municipal unit that correspondence.
